The Phoenix Zoo would like to offer your organization the possible opportunity to visit the Zoo for only \$7.00 per adult and \$5.00 per child. In order to receive this greatly reduce rate, we ask that you fulfill the application requirements and fax or mail them back to us. If your group is not eligible for this special rate, the Zoo offers many more discounts that we can mail or fax to you.

### **Criteria for Reduced Admission**

Care centers and organizations that serve clients who have mental or physical disabilities that require staff assistance for a Zoo visit. *Disability, as defined by the Americans with Disabilities Act, is a physical or mental impairment that substantially limits one or more of the major life activities of an individual. Major Life Activities include functions such as caring for one's self, performing manual tasks, walking, seeing, hearing, speaking, breathing, learning, and working.*

### **Process**

Organizations and care centers will be able to apply to receive reduced admission to the Phoenix Zoo. The information needed for the application process includes:

- Name of organization
- Director/manager name
- Contact person (if other than the director/manager)
- Address
- Number of residents/clients
- Types of mental or physical disabilities
- Pamphlet, brochure, or website with information describing the disabilities of your clients and the services you provide.
- Verification of 501(c)(3) non-profit status, if applicable.
- All guests in the party must be paid for by one person. We will not process separate ticket purchases.

If your group is a part of a larger “**parent**” organization, we may already have your group’s admission status on file. You can call Reservations to find out if your group has already been accepted.

It is more efficient that we accept the “**parent**” organization instead of every group. You can have us fax your parent organization, or you can forward this application to them, or you can fill out the application with the “**parent**” organization information (i.e. address, fax number, etc.).

This information may need to be reviewed periodically, pending any change in the group’s status or the Zoo’s policies.

Accepted groups will be granted a discounted admission of \$7.00 per adult and \$5.00 per child, during regular Zoo hours. (The admission discount will not be valid during ZooLights or other special events outside regular business hours.)

We will let you know if you have been accepted and can proceed with your “field trip” plans. If your application is denied the Phoenix Zoo offers many more discounts that we can mail or fax to you.
